#### **SUMMARY**

Donor Mapping Report 2016-2017 was prepared by the Ministry of Finance and Economic Affairs (MoFEA) for Coordination of the International Economic Aid, in collaboration with the European Commission. Donor Mapping Report (DMR) provides comprehensive information and the analysis of the current Development Assistance channeled into the country by development partners, as well as donors' future activities. Information and statistical data presented in the DMR are based on the financial data of projects/programmes, entered in the database by Donor Coordination Forum (DCF) members, research work of the MoFEA staff as well as the responses to The Gambia.

Donor Mapping Report reflects the interest of The Gambia and the International Community to exchange the knowledge and enhance joint activities directed towards the socio-economic development of the country, and also is the instrument for improvement of mutual cooperation, as well as partnership between government Institutions and donors in the country.

The report provides comprehensive overview of projects and programmes, financed by the development partners, as well as the overview of situation within ten sectors in The Gambia and it includes the period January 2016– July 31<sup>st</sup> 2017.

Total allocation of donor funds to The Gambia in 2016 amounted to  $\notin$ 541,36 million, out of which GMD2,890,313,084.23 million was in the form of grants and GMD340,934,039 million in the form of loans. Compared to the previous period, grant-based Official Development Assistance (ODA) indicates a significant decline in 2011. Largest share of ODA in 2011 was provided in the Infrastructure sector, Economic development and social protection sector and Health sector.

Inclusive with January 1<sup>st</sup> 2016, total allocation of DCF members for The Gambia amounted to GMD798,281,837.50 million, out of which GMD511,599,995.25 million was in grants and GMD286,681,842.25 million in loans. The structure of investments in Sectors in the first seven months of 2016, was very similar to the structure in 2017.

In the observed period, three largest international financial institutions EIB, EBRD and The World Bank provided the loans, as well as the bilateral donor, Germany. At the same time, direct bilateral assistance indicates a trend of gradual decrease and it's channeling through the assistance of the European Union. In 2011, Spain/ AECID, UK/DFID and Netherlands ceased their operations and closed offices in BiH, while Austria/ADC will gradually phase out direct bilateral technical assistance until the end of 2013. During 2012, Republic of Slovenia joined the Donor Coordination Forum.

Finally, Ministry of Finance and Economic Affairs would like to thank the representatives of the various government Institutions and development partners for their active participation in the preparation of the Donor Mapping Report 2016–2017.

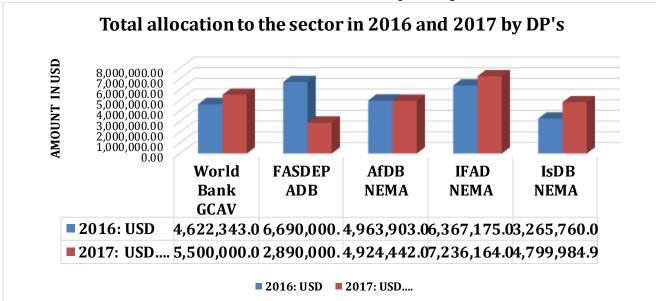

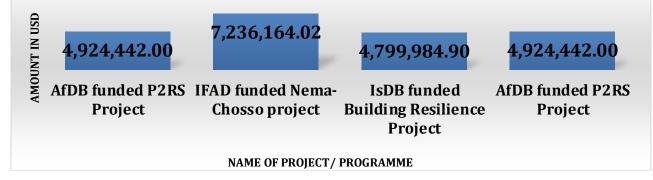

#### **Overview of the ANR**

The ANR sector in The Gambia consist of Crops, livestock, forestry, and fisheries subsectors In terms of employment, agriculture is the most pro-poor sector in the country's economy, accounting for 44 per cent of the population (IHS, 2010). The agriculture and natural resources sector is responsible for generating incomes, improving food security, increasing foreign exchange earnings, and boosting tax revenue. It is the Gambians' main source of income and plays an important role in reducing poverty.

#### Donor Activities in 2016 and 2017

World Banks is intervening in Gambia Commercial Value Chain (GCAV) which is a 17 million project, Agricultural Value Chain (AVCDP) is an AfDB funded project, Nema – IFAD funded, Nema CHOSSO IFAD funded, P2RS – AfDB and IDB funded and FASDEP AfDB funded. The leading donors in the ANR sector in 2016 are ADB with the contribution of GMD64,613,745 million, IFAD with the contribution of GMD28,442,507 million, and WB with the contribution of GMD263,600,000 million. It should also be noted that most of the donor contributions to the ANR sector in 2016 and 2017 are in the form of grants.

#### **Donor coordination**

In 2010, the Government approved The Gambia National Agricultural Investment Programme (GNAIP) in line with line the Comprehensive Africa Agricultural Development Programme (CAADP), which it will continue to implement during the PAGE period. Donor interventions are conceived, financed and implemented within the framework of the GNAIP i.e. from 2010-2015

and it is now expired. It was also conceived and implemented within the ANR policy strategy, which has expired in 2015.

However, these two important strategies (GNAIP and the ANR) are in the process being renewed. The draft report of the new ANR is completed and await for validation while the preparation and consultation for the  $2^{nd}$  generation GNAIP is at an advance stage.

CPCU by an Act of parliament is the coordinating arm of the Ministry of Agriculture. That coordination role is still central to CPCU. Currently the CPCU management is coordinating 6 donor-funded projects two of which are directly housed at the CPCU office in Banjul. 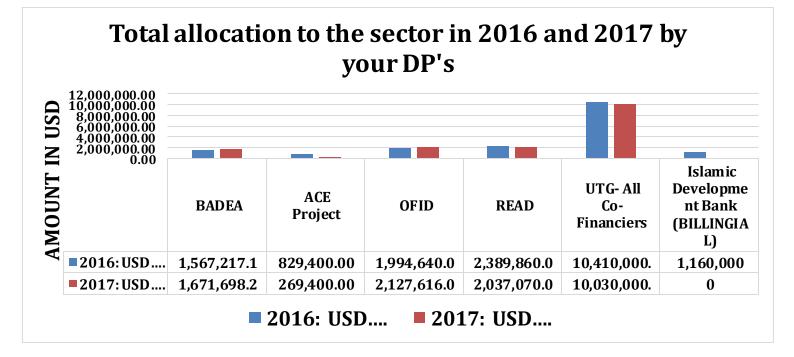

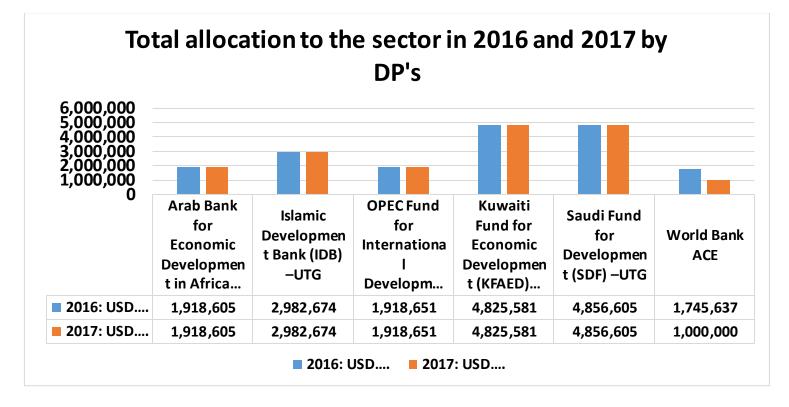

#### **Overview of the Education Sector**

The right of everybody to quality basic education is contained in the 1997 Constitution of The Gambia. In light of this, there is empirical evidence to suggest that the provision of education to any population lays a strong foundation for the sustainable development of any country. It is for this reason that the Ministry of Basic and Secondary Education (MoBSE) execute its mandate to deliver quality education in the areas of early childhood development (ECD), basic education, adult and non-formal education and secondary education. Building upon these foundations, higher and tertiary education is a key factor in human capital formation with the mandate of producing an informed, skillful, and disciplined workforce.

#### Donor Activities in 2016 and 2017

The Donor Coordination Forum (DCF) members active in the Education sector in 2016-2017 are BADEA and OFID support to basic & secondary education schools project, The World Bank African Centres of Excellence (ACE) Project, RESULTS FOR EDUCATION ACHIEVEMENT AND DEVELOPMENT (READ) PROJECT, Saudi Fund for Development, Islamic Development Bank, Kuwaity Fund, BADEA, OFID and Islamic Development Bank. The major projects under the higher education are the University of the Gambia (UTG) Project and Africa Center of Excellence (ACE) Project. The UTG is a multi-donor funded project of 6 partners namely Arab Bank for Economic Development in Africa (BADEA), Islamic Development Bank (IDB), OPEC Fund for International Development (OFID), Kuwaiti Fund for Economic Development

(KFAED) and Saudi Fund for Development (SDF), while the World Bank (IDA Funding) ACE Universities in Central and West Africa.

**The leading donors in the Education sector in 2016** are WB with the contribution of GMD137,077,674 million, IDB with the contribution of GMD52,281,200 million, and GPE with the contribution of GMD14,464,089.75 million. Most donor contributions to the Education sector in 2016 and 2017 are in the form of grants.

#### Support to the strengthening of legal and institutional frameworks

Support to the strengthening the education sector is based on Education Sector Strategic Plan 2006-2015 and Education Policy 2004-2015. The READ Project is financed though the Financing Agreement H916-GM & TF016496, ACE financed by Financing Agreement P126974, OFID financed by Financing Agreement 1584 P, UTG Financed by Financing Agreement GM 0070 and the Bilingual project financed by Financing Agreement GM 0079.

#### Donor coordination

During 2016 and 2017, donors continued to participate in both formal and semi-formal information-sharing meetings in the Education sector. Donors active in the Education sector attended regularly the Donor Coordination Forum (DCF) meetings. Internally, the sector also organizes the quarterly CCM of which all stakeholders are represented. Under the higher education, The Ministry takes part by engaging sector partners, developing proposals, and conducting supervision missions.

#### **Overview of the Health Sector**

The public healthcare system comprises three levels – primary, secondary and tertiary. At present, health services are provided by 546 health posts at the primary level, 38 health facilities at the secondary level, and 6 public referral hospitals. The public health system is complemented by private and Non-Governmental Organization clinics.

The services at primary healthcare level include treatment of minor illnesses, environmental health and sanitation, antenatal care, delivery and postpartum care, home visits, community health initiatives, and basic outpatient services. At the secondary level, basic healthcare is delivered through minor and major health centres. The major health centres serve as the referral points for the minor health centres. At the tertiary level, the general hospitals provide specialized services beyond the level of the major health centres.

#### Donor Activities in 2011 and 2012

The Donor Coordination Forum (DCF) members active in the Health sector in 2016-2017 are EU/EC. The leading donors in the Health sector in 2016 are Global Fund with the contribution of GMD356,530,210.66 million, WB with the contribution of GMD87,500,000.00 million, and WHO with the contribution of GMD72,918,760.00 million, UNICEF with the contribution of GMD5,725,894.95 and WFP with the contribution of GMD850,000 all donor contributions to the Health sector in 2016 and 2017 are in the form of grants.

#### **Overview of Water and Sanitation**

Increasing the population's access to safe drinking water and basic sanitation dramatically reduce their susceptibility to water-borne diseases and increase their likelihood (especially for women and children) from incurring additional expenses related to treatment. In The Gambia, the efforts to ensure access to safe drinking water have been effective over the past years. The proportion of the population with access to safe drinking water increased to 85.8 per cent in 2010 from 69 per cent in 1990, exceeding the MDG target of 84.5 per cent by 2015. Looking at the sub-national level, in general, the water supply situation improved in all the six regions. However, water supply depends on available electricity; therefore, this issue continues to be a major problem in rural health and education facilities as well as at households' level. Sanitation can only progress with adequate quality water and reliable electricity supply.

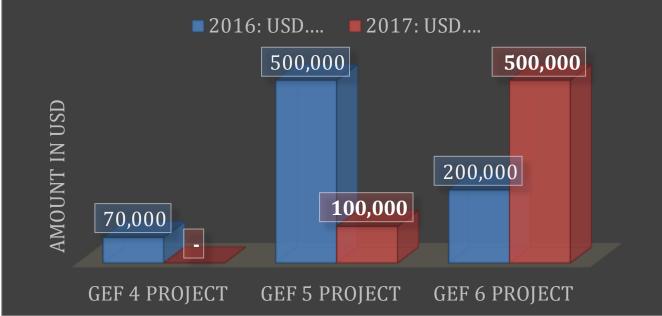

#### **Overview Environment and Climate Change Sector**

The adverse interface between chronic poverty, remote areas and unfavourable agricultural environment can be simply observed in the nature of poverty in The Gambia. The most drought prone ecosystem of Central River North has the highest incidence of poverty. Because of the time lag between causes and effects within global climate systems, the adverse impacts of environmental degradation are likely to persist for decades and generations, even after the global community succeeds in limiting greenhouse gas concentrations in the atmosphere. At the same time, conditions specific to The Gambia<sup>1</sup> make it particularly imperative that the Government mainstreams climate change into its development policies and programmes. Recognizing this, the Government developed and submitted to the UNFCCC Secretariat its First National Communications in 2003 and a National Adaptation Programme of Action on climate change in 2007 to stimulate a critical re-examination of the role of climate on societal and natural systems in the areas of agriculture, fisheries, wildlife, energy, water resources, and forests and woodlands.

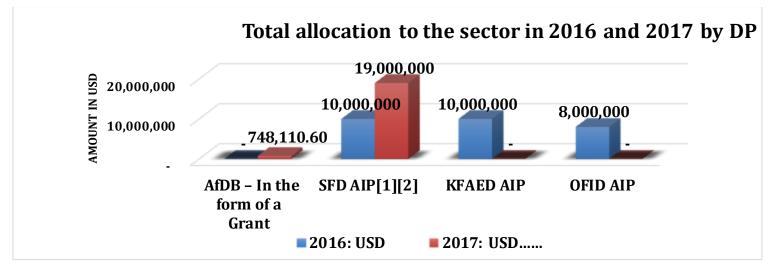

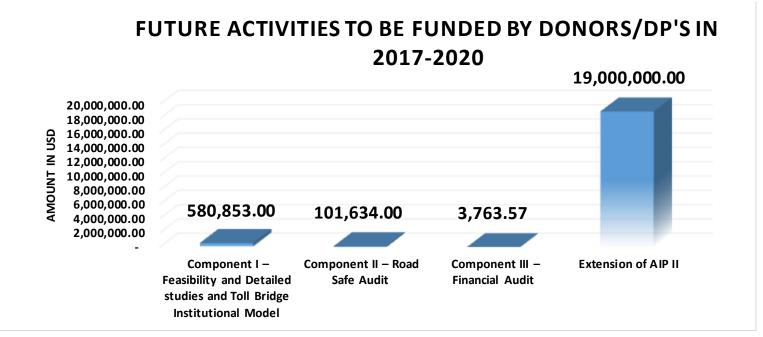

#### **Overview of the Transport Sector**

Accessible and affordable transport infrastructure facilitates and supports economic and social interactions and sustained economic growth. An effective and efficient transport system will boost private sector production by reducing production costs and increasing productivity, and also increase employment opportunities. It also impacts on the lives of people both, directly and indirectly. Directly, by enabling them to attain their basic needs, like access to school, health centres, hospitals, food and energy supplies, and indirectly, through economic growth by enhancing the free movement of people, goods and services, to and from the urban and rural communities, and to the local and regional markets. Employment in the transport sector is created in both construction and operational phases of the transport system. Therefore, improving and modernizing the transport infrastructure will contribute immensely to economic growth and employment generation in the country.

The transport sector has the potential to support the productive capacity and long term expansion of the economy. It is the Government's objective to improve the transport sector's adaptation to climate change and mitigation of greenhouse gas emissions through the improvement to public transport, a better road maintenance regime, better maintained vehicles and through the use of more water-based transport. The Government has taken significant steps towards the attainment of this goal through investment and projects to improve:

- road transport,
- maritime transport,
- river transport, and

• air transport

The Government established the National Roads Authority (NRA) and the Road Fund by an Act of National Assembly (GRTSA ACT, 2003). The mandate of the NRA is to construct, maintain and manage the road network of the country to the standard that facilitates the socioeconomic welfare of the country within the framework of vision 2020.
