#### INTRODUCTION

This brief presents an analysis of Central Government expenditure from January to November 2021. It also aims to inform Senior Management on the composition of total expenditure by different classifications, highlighting the absorption capacity of different Budget Entities (BEs). It further gives an indication of expenditure trends compared to the same period a year earlier. It should be noted that all expenditure referred to in this brief is solely Government Local Fund (GLF), and the report does not factor any donor funds (loans and grants), including projects across the country. In addition, financial data for this report is from the Integrated Financial Management Information System (IFMIS).

#### TOTAL GOVERNMENT EXPENDITURE

Total expenditure as at end November 2021 amounted to **D18.68 billion**, indicating a 10 per cent increase in comparison to expenditure over the same period last year.

Recurrent expenditure amounted to D15.41 billion or 82% of total expenditure for the period, with Personnel Emoluments (PEs) absorbing D4.12 billion, as indicated in Table 1 above. In comparison to 2020, recurrent expenditure increased by 2%.


Meanwhile, expenditure on Capital Development amounted to D3.27 billion, which represents a 71% increase when compared to 2020's Capital Development Expenditure.

Following the approval of the Supplementary Appropriation Bill, there were revisions to the initially approved budget. Table 2 compares expenditure for the different budget classes against the 2021 revised budget. Based on the revisions, Other Recurrent, Subventions and Capital Development were affected. Although PEs were not affected, expenditure as at end November amounted to 85% of the budget for PEs. Capital Development also registered a high expenditure rate, with 84% of the revised budget on Capital Development spent.

Expenditure on Personnel Emoluments increased by 12 per cent compared to last year. Basic Salary expenditure amounted to D1.93 billion, representing 46.92% per cent of total PE, and also increased by 6% year-on-year. Allowance expenditure also increased 22% per cent year-on-year, with expenditure amounting to D1.91 billion.

The table above shows the approved budget for PE in comparison to January - November 2021 expenditure. With the exception of Social Security Contributions, all classes of PEs have consumed more than 85% of their budgets.

## TOP TEN SPENDING BUDGET ENTITIES (BEs)

National Debt Service was the highest spending Budget Entity over the period, with an expenditure of D4.36 billion. The Ministry of Basic and Secondary Education (MoBSE) and The Ministry of Transport, Works and Infrastructure (MoTWI) are next in order, with expenditures of D2.55 billion and D2.40 billion respectively. Expenditure on Debt Service is mainly driven by Interest payments on Treasury Bills & Other Government Securities, while those of MoBSE and MoTWI are driven by Personnel Emoluments and the construction of Roads & Bridges

respectively. In effect, the ten highest spending Budget Entities collectively consumed 85 per cent of total expenditure as of end November 2021.

### TOP TEN SPENDING BUDGET LINE ITEMS

Subventions and Roads & Bridges were the highest spending budget lines over the period, with expenditures of D2.59 billion and D2.11 billion respectively. Settlement of Confirmed Debts was also quite high, with expenditure amounting to D435.70 million.
