INTRODUCTION

This brief presents an analysis of central government expenditure from January to June 2021. It also aims to inform Senior Management on the composition of total expenditure by different classification, highlighting the absorption capacity of different budget entities (BEs). It also gives an indication of expenditure trends compared to the same period a year earlier.

It should be noted that all expenditure referred to in this brief is solely Government Local Fund (GLF), and the report does not factor any donor funds (loans and grants), including projects across the country.

TOTAL GOVERNMENT EXPENDITURE

Government's total expenditure as of end June 2021 amounted to **D9.57 billion**, representing a 22 percent increase from the same period last year.

Personnel Emolument (PE) and Other Recurrent (OC) collectively consumed 42 percent of total expenditure. Meanwhile, PE has increased from D1.99 billion to D2.24 billion, representing a growth of 12 percent.

In comparison to last year, Debt Service increased by 156 percent from D906 million to D2.32 billion, whilst expenditure on Development has increased by 89 percent.

Table 2 above compares the different budget classes against the 2021 approved budget, highlighting the absorption capacity by budget class. Capital Expenditure is the highest absorptive budget class, with 59 percent of its budget consumed as at end June 2021.

The different budget classes have collectively consumed 43 percent of the approved budget during the period under review.

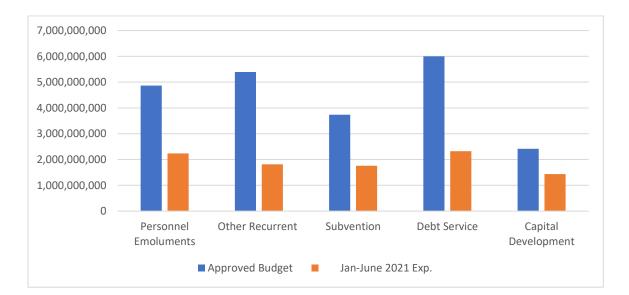


Chart 1: Central Government Expenditure for End June 2021 compared to Approved budget, Source: IFMIS

Personnel Emolument increased by 12 percent relative to last year. Basic Salary constitutes 47 percent of total PE, and registered a growth of 7 percent, increasing from D976 million in 2020 to D1.05 billion in 2021. Allowances have also increased by 21 percent as compared to the same period last year, from D858 million to D1.04 billion.

The table above shows the approved budget for PE as compared to June 2021 expenditure. ECA and Allowances have consumed 57 percent and 48 percent of their respective approved budgets during the period under review.

TOP TEN SPENDING BUDGET ENTITIES (BEs)

The top ten highest spending Budget Entities collectively consumed 87 percent of total expenditure as of end June 2021. National Debt Service and Ministry of Basic and Secondary Services are the highest spending entities, consuming 24 and 14 percent of total expenditure respectively. National Debt Service expenditure has increased drastically by 156 percent,fromD906million in June 2020 to D2.3 billion in June 2021.

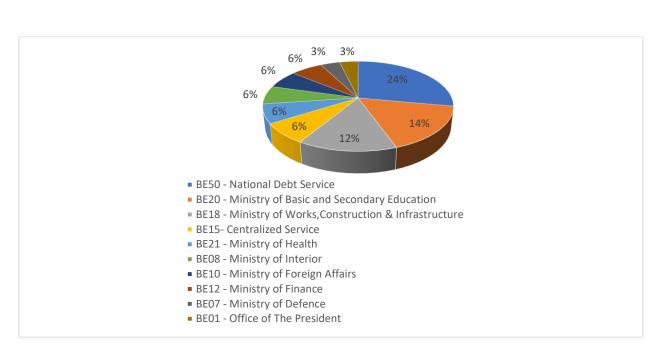


Chart 2: Top Spending Budget Entities as at End June2021

I. TOP TEN SPENDING BUDGET LINE

Application software systems & liscences has registered the highest expenditure, with 133 percent of its budget absorbed by the end June 2021. This increase is largely attributed to the expenses associated with voter registration. In addition, Land compensation and Settlement of Confimed debts have consumed 78 and 67 percent of their approved budgets respectively, as of end June 2021.
