INTRODUCTION

This brief presents an analysis of central government expenditure from January to July 2021. It also aims to inform Senior Management on the composition of total expenditure by different classification, highlighting the absorption capacity of different budget entities (BEs). It also gives an indication of expenditure trends compared to the same period a year earlier.

It should be noted that all expenditure referred to in this brief is solely Government Local Fund (GLF), and the report does not factor any Donor Funds (loans and grants), or projects across the country.

TOTAL GOVERNMENT EXPENDITURE

Government's total expenditure as of end July 2021 amounted to **D10.86 biilion**, representing a two percent increase from the same period last year.

Personnel Emolument (PE) and Other Recurrent (OC) collectively consumed 45 percent of total expenditure. Meanwhile, PE has increased from D2.36 billion to D2.59 billion, registering a growth of 10 percent.

In comparison to last year, Capital Development increased by 76 percent from D840 million to D1.48 billion, mainly due to the implementation of various road infrastructure Projects by the

Minsitry of works.

Table 2 above compares the different budget classes against the 2021 approved budget, highlighting the absorption capacity by budget class. Capital Expenditure is the highest absorptive budget class, with 61 percent of its budget consumed as at end July 2021. This increase can be attributed to road works across the country.

The different budget classes have collectively consumed 49 percent of the approved budget during the period under review.

Chart 1: Central Government Expenditure for End July 2021 compared to Approved budget, Source: IFMIS

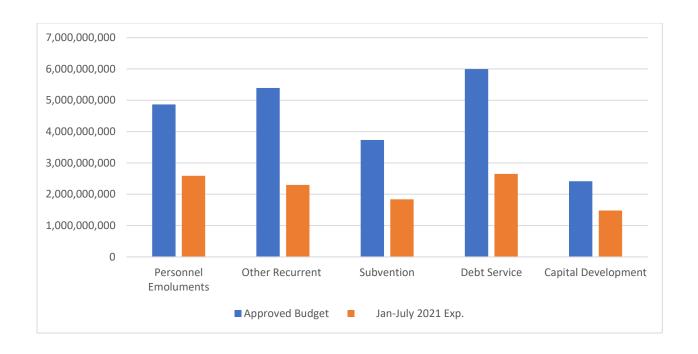

Personnel Emolument increased by 12 percent relative to last year. Basic Salary constitutes 47 percent of total PE, and recorded a growth of 8 percent, increasing from D1.12 billion in 2020 to D1.21 billion in 2021. Allowances have also increased by 19 percent as compared to the same period last year, from D1 billion to D1.20 billion.

The table above shows the approved budget for PE as compared to July 2021 expenditure. ECA and Allowances have consumed 64 percent and 56 percent of their respective approved budgets during the period under review.

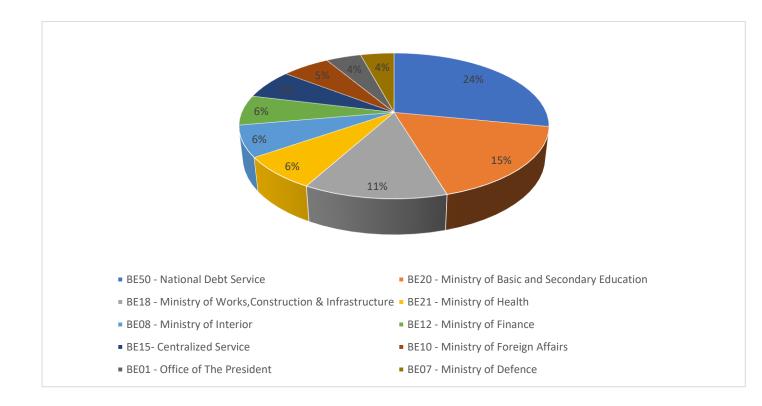
TOP TEN SPENDING BUDGET ENTITIES (BEs)

The top ten highest spending Budget Entities collectively consumed 87 percent of total expenditure as of end July 2021. National Debt Service and Ministry of Basic and Secondary Services are the highest spending entities, consuming 24 and 15 percent respectively of total expenditure. Ministry of Works expenditure has increased by 123 percent, from D532 million in July 2020 to D1.88 billion in July 2021.

I. TOP TEN SPENDING BUDGET LINE

Land Compensation registered as the highest absorbed budget line, with 81 percent of its budget absorbed by end July. Meanwhile, Settlement of Confimed debts and Food and Food Services have both consumed 67 percent of their approved budgets during the period under review.
