INTRODUCTION

This brief presents an analysis of central government expenditure from January to May 2021. It also aims to inform Senior Management on the composition of total expenditure by different classification, highlighting the absorption capacity of different budget entities (BEs). It also gives an indication of expenditure trends compared to the same period a year earlier.

It should be noted that all expenditure referred to in this brief is solely Government Local Fund (GLF), and the report does not factor any donor funds (loans and grants), including projects across the country.

TOTAL GOVERNMENT EXPENDITURE

Government's total expenditure as of end May 2021 amounted to **D7.88 Biilion**, representing a 13 percent increase from the same period last year.

Personnel Emolument (PE) and Other Recurrent (OC) collectively consumed 43 percent of total expenditure. Meanwhile, PE has increased from D1.81 billion to D1.86 billion, representing a growth of 3 percent.

In comparison to last year, Debt Service increased by 66 percent from D1.17 million to D1.95 billion, whilst expenditure on Development has increased by 152 percent.

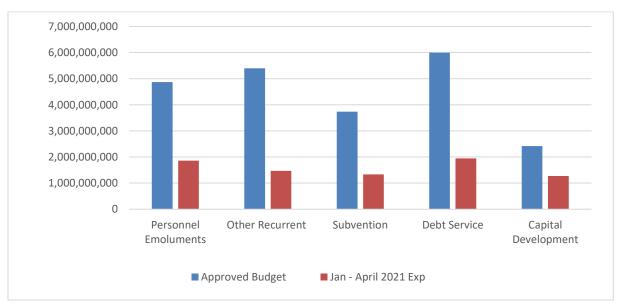

Table 2 above compares the different budget classes against the 2021 approved budget, highlighting the absorption capacity by budget class. Capital Expenditure is the highest absorptive budget class, with 53 percent of its budget consumed as at end May 2021.

The different budget classes have collectively consumed 36 percent of the approved budget during the period under review.

Personnel Emolument increased by 39 percent relative to last year. Basic Salary constitutes 47 percent of total PE, and registered a growth of 31 percent, increasing from D664 million in 2020 to D870 million in 2021. Allowances have also increased by 52 percent as compared to the same period last year, from D571 million to D866 million.

The table above shows the approved budget for PE as compared to May 2021 expenditure. ECA and Basic Salary have consumed 48 and 39 percent of their respective approved budgets during the period under review.

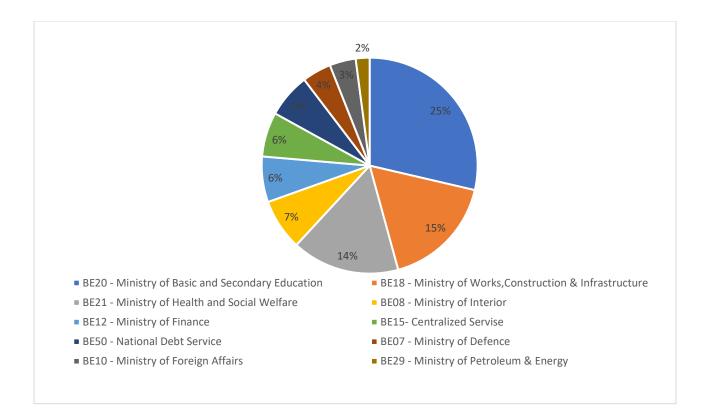
TOP TEN SPENDING BUDGET ENTITIES (BEs)

The top ten highest spending Budget Entities collectively consumed 86 percent of total expenditure as of end May 2021. National Debt Service and The Ministry of Basic & Secondary Education are the highest spending ministries, consuming 25 and 15 percent of total expenditure respectively. The Ministry of Works, Construction & Infrastructures' spending has increased drastically over time by 121 percent, from D497 million in May 2020 to D1.09 billion in May 2021. This increase can be largely attributed to the increase in cost associated with the contruction of roads.

I. TOP TEN SPENDING BUDGET LINE

Subvention and Roads & Bridges registered the highest expenditure, with D1.3 billion and D988million expended. Meanwhile, Land compensation consumed 75 percent of its approved budget as of end May 2021, while Roads & Bridges and Settlement of confirmed debts consumed 60 percent and 49 percent of their budgets respectively.
